

Town of Islip Industrial Development Agency Mission Statement and Measurement Report

A. Agency Mission Statement

Local Public Authority Name: Town of Islip Industrial Development Agency

Fiscal Year: January 2015 – December 31, 2015

Enabling Legislation: The Town of Islip Industrial Development Agency (TOIIDA) was established in 1974 by an act of the New York State Legislature. Industrial development agencies (“IDAs”) are formed under Article 18-A of New York State General Municipal Law, as public benefit corporations. IDAs were created to actively promote, encourage, attract and develop job and recreational opportunities and economically-sound commerce and industry in cities, towns, villages and counties throughout New York State (the “State”). IDAs are empowered to provide financial assistance to private entities through tax incentives in order to promote the economic welfare, prosperity and recreational opportunities for residents of a municipality (“Benefited Municipality”).

Mission Statement: The Mission of the Town of Islip Industrial Development Agency is to promote and foster economic growth, provide employment opportunities and to improve the overall quality of life of the residents of Islip Town. TOIIDA accomplishes this mission by fostering the expansion and retention of our existing business base and by marketing our community as "business friendly" facilitating new business attraction in order to build a sustainable long-term economy.

2015 Measurements:

1. Secure new capital investment of \$20 Million in 2015 – **ACTUAL \$105,095,945**
2. Secure the retention/creation of 100 jobs in 2015 – **ACTUAL 1,651 (Retain 1,022 – create 629)**
3. Induce 5 new projects in 2015 – **ACTUAL 17**
4. Close on 5 new/existing projects in 2015 – **ACTUAL 21**
5. Work towards compliance with all PAAA and PARA rules and regulations – **YES, ONGOING**
6. Explore/strengthen all new and existing regional economic development initiatives and efforts, especially State designated Regional Councils – **YES, ONGOING**
